### Стипендії DAAD

### Програма DAAD/OSI



Німецька служба академічних обмінів (DAAD) та Інститут відкритого суспільства (OSI) проводять спільну стипендійну програму для випускників ВНЗ в галузі гуманітарних, соціальних та суспільних наук з країн Південного Кавказу, Центральної Азії, Молдавії та України. Стипендії надаються спільно DAAD та OSI з метою навчання у магістратурі або аспірантурі у німецьких ВНЗ.

**Метою програми DAAD/OSI** є покращення становища в сфері викладання та досліджень в рамках гуманітарних та суспільних наук у цих країнах, а також налагодження контактів між вченими цього регіону, на основі яких можуть самостійно розвиватись подальші міжнародні контакти.

#### Тривалість стипендії:

Стипендії надаються для навчання на максимально дворічних магістерських програмах або на трирічну аспірантуру.

#### Розмір стипендії:

Студентам магістерських програм: 750 євро щомісячно.

Аспірантам: 1000 євро щомісячно.

Всім учасникам оплачується проїзд та, якщо необхідно та передбачено програмою, вартість мовних курсів.

Аспірантам після двох років перебу-

вання буде оплачена поїздка додому.

Стипендіатам на магістратуру та аспірантуру, в яких залишилися вдома діти дошкільного віку, може щорічно сплачуватися максимально 3-тижнева поїздка додому.

Виплата грошової допомоги на перебування чоловіка/дружини та дітей по цій програмі є виключеною.

Після початку навчання у Німеччині для всіх учасників буде організовано підготовчу зустріч, крім того, всі учасники цієї програми в рамках свого навчання у Німеччині щорічно братимуть участь у організованій з боку DAAD та OSF піврічній конференції.

Для кураторства на післядипломних програмах, якщо на одній програмі навчається більше трьох стипендіатів, передбачений тьютор.

#### Вимоги до пошукачів:

рамках програми DAAD/OSI підтримуються переважно гуманітарні, суспільні та соціальні науки, які недостатньо представлені в країнахучасницях програми. До них належать політологія, соціологія, міжнародні відносини, право, економіка, державуправління, управління освітою філософія. В окремих випадках підтримуватися пошукачі можуть інших спеціальностей, якщо спеціальності належать до соціальних та гуманітарних наук.

Протягом року до початку програми пошукачі мають проживати в Україні!

#### Тривалість:

Стипендія надається на строк від одного до трьох місяців в залежності від плану роботи пошукача.

#### Розмір стипендії:

Щомісячна стипендія становить, залежно від наукового ступеня, 2000 євро для наукових співробітників (викладачів, доцентів, як правило, зі ступенем кандидата наук) та 2150 євро для професорів, у виключних випадках - 2300 євро.

Крім того, DAAD виділяє, як правило, певну суму на проїзд, якщо це не беруть на себе організації на Батьківщині пошукача або інша сторона.

Допомога на перебування членів сім'ї не надається.

#### Вимоги до пошукачів:



The call for applications for admission to the IMT Ph.D. Program is now open.

The Doctoral program is divided into four tracks:

The Track in Computer, Decision, and Systems Science (CDSS) aims to equip researchers and professionals with a wide knowledge of the theoretical computer foundations of science, informatics and system analysis applicable to a large variety of real-life problems of industrial, managerial, economic, and societal interest. Such elements include control systems, management science, optimal decision making and numerical optimization, image analysis and pattern recognition. The objective of the program is to provide Ph.D. candidates with the necessary scientific competence to master the theoretical aspects of the discipline, to propose original research ideas, and to develop numerical algorithms, managerial solutions and software tools for applying

the new concepts to practical applications. The Track in Computer, Decision, and Systems Science is organized into four main curricula:

- \_Computer Science
- \_Control Systems
- \_Image Analysis
- \_Management Science

The Track in **Economics** trains researchers, professionals and experts in political economy, applied public economics, industrial economics, with a focus on comparative institutional analysis, on the empirical analysis of real and financial markets, on macroeconomic policy. With its theoretical, quantitative and institutional approach, the program meets the increasing demand for highly qualified professionals, too analyze, plan, and manage concrete applications of political economy.

The program in **Management** and Development of Cultural Heritage aims at providing prospective professionals operating in the field of management of culture and cultural heritage with specific know-hows.

It also promotes research offering the students a lively contact with different research approaches and methodologies applied in the research fields related to cultural heritage and art history.

Track in **Political** History aims to provide students with the most advanced and update-to-date theoretical and methodological instruments for the historical study of nineteenth and century politics, twentieth policies, political institutions and political ideas. The program aims in particular at bridging two divides: that between the theoretical approach of social scientists (political scientists and theorists, economists and anthropologists, global) and the idiographic approach of historians; and that between national and nonnational (international, cross-national, transnational) political histories. By focusing on the theoretical competences necessary to understand political history, the core courses will aim especially at overcoming the first divide. By comparing national experiences, focusing transnational phenomena and analyzing the interplay between national and supranational arenas, the core seminars will especially aim at overcoming the second divide.

**Duration**: 3 years

**Language**: Courses and seminars are held in English. Foreign Ph.D. students are required to attend an Italian Language and Culture Course.

Classes start in February 2013.





#### **Description**

WCO will award number a scholarships for the Master's Degree programme in Strategic Management and Intellectual Property Rights (IPR) at the Aoyama Gakuin University (AGU), Tokyo, Japan from April 2013 to March 2014. The Master's Degree programme comprises two segments: an academic segment and a practical segment. The academic segment starts with focused teaching of foundational skills in strategic management and IPR. It then moves to a range of applied topics which help students



understand how to design, implement, and evaluate public policies, in particular Customs policy, in accordance with development strategies for organizations.

The practical segment is taught in cooperation with Japan Customs, including the Japan Customs Training Institute.

#### **Eligibility**

The candidates should be in good health, preferably below 40 years of age as of 1 April 2013

The recipients of Scholarships under this Programme will enrol for the Master's Degree programme in Strategic Management and Intellectual Property Rights (IPR) programme at the AGU

This Scholarship is for one academic year starting from April 2013. There will be a preparatory course in March 2013 for a few weeks before the start of the Programme

The candidates should be Customs officers fully proficient in English

(a minimum TOEFL score of internet Based Test (iBT) 79 / Computer-Based Test (CBT) 213 / Paper Based Test (PBT) 550, IELTS 6.0, or its equivalent qualification to prove their language proficiency)

They should have a university degree or equivalent qualification

The candidates should have at least 3 years of work experience in Customs and should have assessed potential for advancement

In the selection, preference will be given to candidates who have experience in IPR border enforcement, and who are expected to work in the IPR-related section of their Customs administration after this Scholarship Programme.

#### **Scholarship**

#### **Short project description**

Weinvestigate intra-industry imitation in discretionary financial disclosure and management commentary. Imitation of discretionary reporting content and related reporting choices may be conceived as a rational response to discretion and related ambiguity in order to meet explicit and implicit industry norms. This issue is crucial in the current debate on a principles-based versus rules-based approach in the reporting standard-setting process. We will address the following research questions: (1) What is the extent





# Application procedure for Fellowships



Applicants are required to have developed distinct and individual academic profile. Applicants should therefore generally have at least worked as assistant professors or as junior research group leaders or be able to provide evidence of several years of independent academic work. Academics from all over the world specialising in all kinds of disciplines are eligible to apply.

#### **Scholarship Value**

A monthly grant of 2,450.00 EUR is paid. This includes a standard mobility allowance and a payment towards health and liability insurance. Additional benefits:

Candidates complete the «UNIL Master's Grant» form and submit their application to the Office for socio-cultural affairs (SASC, Unicentre, University of Lausanne, CH-1015 Lausanne, info. sasc@unil.ch) by 15 December 2012 at the latest. The application is examined by the University Rectorate to determine whether the candidate is admissible.

In the event of a positive decision, the application is forwarded by the SASC to the UNIL Faculty responsible for the Master's on which the candidate wishes to be enrolled. The Faculty selects applications and notifies the SASC of its opinion based on the candidate's qualities, motivation and suitability for the Master's programme. The SASC forwards shortlisted applications to the selection committee which will award grants to students meeting all criteria according to the available budget.

программы – Цель поддержка научно-исследовательских инициатив, направленных на то, чтобы поделиться опытом Польши в осуществлении системных изменений, рыночной экономики, формулы верховенства закона и гражданского общества. Способствует привлечению иностранных ученых к совместным исследовательским проектам с польскими партнерами. Программа осуществляется путем научноисследовательской стажировки профессиональной стажировки. Стажировки проводятся по согласованию с польскими университетами и исследовательскими центрами. Грантополучатели направлены в соответствии с предметом своих исследований в центры, с которыми они хотели бы сотрудничать и/или совместно реализовать исследовательский проект. Пребывание ученого в Польше длится от 2 до 6 месяцев. Стоимость научной стипендии составляет 2500 злотых в месяц.

В рамках стипендии после научноисседовательской стажировки есть возможность пройти профессиональную стажировку в избранном учреждении (например, в министерстве, органах местного самоуправления, НПО, СМИ) в Польше.

- •политика развития и гуманитарная помощь.



integration will be promoted within the spirit of new governance and through active participation - creating an awareness of true European citizenship;

 to give young university graduates the opportunity to put into practice knowledge acquired during their studies, particularly in their specific areas of competence. To introduce these graduates to the professional world and its constraints, duties and opportunities.

# The European Commission, through its official traineeships scheme:

- benefits from the input of young enthusiastic graduates, who can give a fresh point of view and up-todate academic knowledge, enriching the everyday work of the European Commission;
- creates a pool of young people with first-hand experience of and trained



in European Commission procedures, who will be better prepared to collaborate and co-operate with the European Commission in the future;

 creates long-term «goodwill ambassadors» for European ideas and values, both within the European Union and outside.

## In order to apply you must:

- have completed the first cycle of a higher education course (university education) and obtained a full degree or its equivalent by closing date for applications;
- not have completed a traineeship in another European Union institution or body;
- have a very good knowledge of English or French or German;

A training grant may be awarded to the trainee. The grant is currently EUR 1047,55 per month. Disabled trainees may receive a supplement to their grant.

# The purpose of in-service training is in particular:

to provide them with practical knowledge of the working of Commission departments; to enable them to acquire personal experience by means of the contacts made in the course of their everyday work; to enable them to further and put into practice the knowledge they have acquired during their studies and in particular in their specific areas of competence.
